Expression of interest for setting up of effluent treatment plant for fish markets

Expression of interest is invited from reputed firms/companies for the supply, installation, testing and commissioning of effluent treatment plant having a capacity of 5KLD/ 10KLD/ 15KLD per day for the various fish markets being established by KSCADC at the different location of Kerala state. The selected bidder will have to carry out operation and maintenance for 1 year after satisfactory commissioning of the plant. The necessary land for the project will be provided by KSCADC and the fish effluent water may be brought to the plant from the nearby fish markets by the bidders.

The firm/company should submit necessary certificates of experience for eligibility as mentioned below with other technical details such as brief process description, waste utilization, method of functioning, process, other relevant details etc.

Pre – Qualification criteria

- a) JV/ consortium is not permitted.
- b) To be eligible to qualify, the company should have commissioned atleast three effluent treatment plants of minimum 5KLD per day or more based on any organic effluent waste in last 5 years.
- c) Bidder should have minimum 3 working effluent treatment plants presently.
- d) Bidder should be in the business of effluent treatment plant, installation in his own name for past 5 years.
- e) Average annual turn over in the past three years should be INR 2 crores.
- f) Subcontracting of the project implementation cannot be done.
- g) There shall be sufficient period of replacement warranty of components and AMC services.
- h) Bio data of the competent technical and non technical team members may be attached.

Note:- Necessary documentary proof should be enclosed with EOI.
