

## **I. EQUIPMENTS AND ACCESSORIES FOR RETAIL FISH OUTLETS**

Competitive bids are invited for the supply, installation, testing and commissioning of various equipments in retail fish outlets being established by KSCADC, from the reputed firms/companies/suppliers of various items. The Technical Specifications specified in this section are minimum suggestive. The vendor will have to supply the below mentioned equipments that will best suited and meet the present and future requirements. Bids not meeting the minimum specifications are liable to be rejected. In case the equipment quoted exceeds/differ the tender technical specifications, the same should be clearly defined by the bidders. The quantities shown against each item are approximate. Bidders can participate either for full items or for individual item.

### **A. Technical Specifications**

#### **1. Side open freezer – 30 nos. (Approx.)**

- Side open freezer with hard top which can be used as counter top
- Inside surface shall be of food grade material
- Compressor make –Emerson/Tecumes/ Danfoss /equivalent quality
- Outside Dimension-150×60×80cm
- 350ltr capacity
- Shall be capable of using it as chiller & freezer with temperature adjustment
- Lockable castors, Magnetic gasket & Adjustable ss wire trays inside
- Thickness of Puf insulation -100mm

#### **2. Display Hot Case – 30 nos. (Approx.)**

- Outside Dimension-90×60×110cm
- Attachment-8mm straight glass, glass shelves, light fittings on all shelves, lockable castors, heating coils, power indicator, On-Off switch
- Aesthetic finish

#### **3. Microwave Oven – 30 nos. (Approx.) – Branded**

- Microwave capacity-Minimum 30 litre capacity
- Microwave type –Grill/combination
- Cavity type-Powder coated
- Power output-1000 watt
- Programme panel –Touch type with LED display

**4. Mini master oil fryer – 30 nos. (Approx.)**

- Electric
- Capacity - 4 litres
- Single tank
- Dimension -200×450×200mm
- Compact,portable,light weight and most suitable for counter type frying jobs
- Frying pan completely removable for convenient cleaning
- Heater shall be suitable for continuous operation
- Food grade stainless steel wire mesh frying basket with detachable handle

**5. Coffee/tea/lemon tea vending machine – 30 nos. (Approx.)**

- Capacity 10-20lts
- Easy to clean and maintain

**6. Fly Catcher – 30 nos. (Approx.)**

- Dimension-20”×12.5”
- Material-Extruded aluminium
- 2×15w UVA blue tube
- Weight not more than 4kg
- Must suit a small kiosk of less than 150sqft

**7. Bottle cooler – 30 nos. (Approx.)**

- 60 litre capacity

**8. Water storage tank – 30 nos. (Approx.)**

- 500 litre capacity, food grade PVC/FRP box type water tank ( Transparent)

**9. Wash basin – 30 nos. (Approx.)**

- Stainless steel wash basin sink with 60×40cm dimension with drain board

**10. Chair - 30 nos. (Approx.)**

- Raised rotatable chair without arm
- Stainless steel frame with cushion top

**11. Water Dispenser – 30 nos. (Approx.)**

- 20ltr capacity food grade plastic water dispenser

**12. Waste bin with lid - 60 nos. (Approx.)**

- Plastic waste bin with lid with the option of foot operation (Large size)

**13. Air tight containers (Food Grade plastic materials) - 300 nos. (Approx.)**

- Dimension - 38.1×24×11.6cm
- White colour

**14. Product dispenser - 30 nos. (Approx.)**

- 1mtr high stand with minimum 3 racks with 40×20cm dimension
- Material - Marine plywood with 12mm thickness
- The logo and other details has to be printed in the stand

**15. Stove & kitchen utensils – 30 Nos of sets (Approx)**

One set shall have the following,

- i) Single burner stove – Mild steel frame with brass burner, industrial type (one no. each)
- ii) Stainless steel plates – Full plates, Food grade stainless steel, dia - 12 inches, rimless, easy to wash (5 nos. each).
- iii) Steel tea spoons - Food grade stainless steel, length – 6” (6 nos. each).
- iv) Steel tongs - Food grade stainless steel, red rubber handle, easy and safe to use and wash (8 nos. each).
- v) Plastic bowls – Food grade plastic containers, small (2 nos. each). & medium size (3 nos. each).
- vi) Scissors – Stainless steel blades with pointed tip for improved detail cutting, sturdy handle with 8” length, accommodates right and left handed users (2 nos. each).
- vii) Casserole – 284 × 195 mm (Diameter × Height), 3.5 litre capacity, material: propylene and steel (5 nos. each).
- viii) Microwavable plates – Material: ceramic, 25cm dia, easy to clean (6 nos. each).
- ix) Stainless steel colander - Food grade stainless steel, 22.5 × 11 cm, material: steel or stainless steel and S.S metal mesh, finishing: nickel plating, easy to clean, Handle: Customized design (10 nos).
- x) Non stick frying pans – Medium size (2 nos. each). ISI Mark.

## **B. Tender Conditions**

1. EMD shall be furnished by means of demand drafts of a Nationalized Banks drawn in favour of Managing Director, KSCADC payable at Trivandrum.
2. A preliminary Agreement in the prescribed format (as per the tender document) on stamped paper worth Rs. 100/-) shall be executed and furnished along with the tender document.
3. 5% of agreed value shall be furnished as security deposit in the form of bank guarantee of a Nationalized/scheduled Banks for a period of one year from the date of issue of satisfactory completion report.
4. The equipments shall be supplied at the site as specified by KSCADC in the various districts at suppliers cost.
5. The electrical and electronic components shall have warranty given by the manufacturer.
6. The equipments shall be commissioned within three months on receipt of the supply order as well as handing over of the site.
7. The rates quoted must be inclusive of all taxes, duties, freight, labour charges etc.
8. The year wise terms of Annual Maintenance Contract (AMC) for the tem vide Sl. No. 1 to 6 shall be submitted along with the tender for a period of 5 years.
9. Firm/company/ authorized suppliers declared by Kerala Govt., including KSCADC to be ineligible to participate for corrupt, fraudulent or any other unethical business practices shall not be eligible during the period for which such ineligibility is declared.
10. KSCADC do not bind themselves to accept the lowest or any bid and reserves the right to reject any or all bids with/without any reason and accept/prefer any bid or Bidder without assigning any reason and also reduce or extend the period of contract without assigning any reason.
11. KSCADC reserves the right to contact and verify Bidder's information, references and data submitted in the Bid proposal without further reference to the Bidder.
12. The absence of specifications details regarding any equipment to be supplied under this project implies that best general practices will prevail and that first quality material and workmanship will be applied as per the discretion of KSCADC. Certification standards, when available, for the to-be-installed equipments and materials, will prevail.

13. The KSCADC reserves the right to vary the quantities and fix a delivery schedule. KSCADC also reserves the right to order additional quantities at a price not more than the price accepted after this tender for a period of six months from the date of order placement.
14. KSCADC reserves the right to effect changes in the Technical Specifications. Any such change will be notified in writing to all those who have purchased this Document. In case, any of the bidder have submitted the bids before receiving the notification of changes, will be allowed to submit a revised tender accordingly.

Note:-

- a) The tender shall be put in a single sealed cover super scribing the wordings “Bid for equipments and accessories for retail fish outlets”.
- b) The following shall be submitted along with the tender,
  - (i) The bidder shall submit Customer Satisfaction Report for items 1, 2 and 5 from at least one customer to prove his experience in supply and installation of these equipments.
  - (ii) The bidder shall submit brochures of the equipment item quoted.
  - (iii) The bidder shall submit samples of items quoted on tender opening.
