SUBMISSION OF DOCUMENTS

The envelope containing the filled form (with relevant enclosures) may be placed in the drop box provided at KSCADC, Head Quarters at Jagathy, Thiruvananthapuram or sent by speed post.

1. VALIDITYOF EOI

- 1. The rates quoted or Tendered would be valid up-to the contract period. Extended period as decided by the Managing Director of KSCADC, Thiruvananthapuram.
- 2. The Managing Director of KSCADC, Thiruvananthapuram will not entertain any price revision during the validity period of EOI or extended period thereof.
- 3. If any information provided by the bidder in both Technical and Commercial Bids are found to be factually false or misleading, such Tenders will be summarily rejected at any time during the validity of the tender and liable for penalties as applicable.
- 4. If any complaint of blacklisting of the bidder by any State Government or GOI, such applicant is liable for rejection at any time during the validity of the EOI period.
- 5. The bidder is liable for rejection due to the following reasons:
 - a. Incomplete/non-submission of any of the documents sought for.
 - b. For any disqualification made by the Department/GOI for becoming blacklisted
 - c. Default in the previous transaction.
 - d. Incomplete technical and commercial bids submissions

2. OPENINGOF EOI&TENDERSSCRUTINY:

- 1. The opening of Technical Bids will be done in the presence of the bidders or their authorized representatives who choose to be present and the bidders Scrutinizing Committee will conduct preliminary scrutiny.
- 2. The Commercial Bids in respect of those EOI whose Technical Bids are qualified will be opened in the presence of the bidder who choose to be present by the EOI Scrutinizing Committee appointed by the Tender Accepting Authority.
- 3. No documents or queries will be accepted after opening of the EOI

3. EOI RATES:

1. The rates quoted by the bidder shall be in percentage of the consultancy charges actually obtained for the project excluding taxes

4. SCOPE OF SERVICES:

- 1. The consultant firm should canvas the work from other state governments, Union Territories and other Departments on behalf of KSCADC with the support and guidance of KSCADC.
- 2. The consultant firm should complete the client requirement as per the agreement conditions on behalf of KSCADC in time.
- 3. The consultant firm should follow up for getting payment from the client and share with KSCADC as per the agreed percentage.
- 4. An amount of Rs. 2,50,00/- as S.D. in favor of MD, KSCADC in the form of DD

5. PENALTIES FOR NON-COMPLIANCES, VIOLATIONS & NONPERFORMANCE:

- 1. On approval of the EOI if the bidder does not perform his obligations as per the EOIs terms and conditions and as per the agreement executed by the bidder such bidder shall be blacklisted and Department shall reserve all rights to make alternative arrangements to make available the service.
- 2. Violation of any of the terms and conditions of the Tender or the agreement executed by the Consultant is liable for stringent actions like forfeiting of SD amount and disqualification for such departmental tenders for a period of three years or any other punishment as deemed fit in the opinion and judgment of the depending on the nature of violation

6. LEGAL TERMS AND COMPLIANCES:

- 1. The successful bidder shall execute an agreement covering the Terms and Conditions of EOI onRs.100/-Non-Judicial Stamp Paper or as per the existing procedure at his cost, at the time of acceptance of tender.
- 2. The share of the consultant will be paid by KSCADC within 7 days on receipt of payment from the client. Any advance payment are made on producing a Bank Guarantee
- 3. In respect of any dispute arising out of implementation of the bid, the decision of the Managing Director of KSCADC shall be final.
- 4. For any legal remedies, the courts at State of Kerala shall only have the jurisdiction.

7. OTHERCONDITIONS:

- 1. The conditional proposals will be rejected.
- 2. The EOI Accepting Authority reserves the right to reject the EOI even after opening of Technical bid or Commercial Bid without assigning any reasons whatsoever.

I. Scope of Services shall be

- 1. To assist beneficiary in preparing required documents.
- 2. Preparation of DPR.
- Selection of efficient/modern machineries.
- 4. Preparation of layout.
- 5. Preparation of drawings.
- 6. Preparation of detailed estimate as per PWD/CPWD rates. (Prevailing in the state)
- 7. Designing and guidance in implementation of the project as per and Guidelines of funding agency.
- 8. Submission of proposal and follow-up for final sanction from Funding Agency.
- 9. To assist in tender process if required.
- 10. Preparation of working drawings, supply of updated and additional drawings if required.

- 11. Consultant shall advise the client on the progress of work and visit the site for meetings/advice/guidance during the implementation of the project. If their presence is essential for more than three visits, the same shall be charged extra.
- 12. Conducting required surveys, obtaining clearness.
- 13. Preparation of structural design after conducting Geo Tech surveys if required.
