

Chennaveli Fishing Village

(Mararikulam North GP - Kanjikuzhy Block)

A Brief Profile of the Chennaveli Fishing Village

Chennaveli fisheries village is spread over two wards of Mararikulam North Gram Panchayat. The coastal wards of this village are 1 and 10. The village has a total of 850 houses and 891 households are living there. Among them, 50 households are landless or presently living as a joint family. Regarding the housing situation in the village, it is noted that 29.41 percent houses are pucca, 52.94 percent are semi-pucca and 17.65 percent houses are kachha houses. About 85.29 percent of the existing houses in the village have sanitary toilets. Safe drinking water is available to 90 percent of the existing houses. Most of the houses in the village (94.12 %) are electrified. It is noted that 230 persons from the fisher folk community are insured with the Fisheries Board (Matsya Board). And 12 persons are covered under the old age pension scheme and 3 persons are covered under widow pension scheme during 2007-08 in this village.

Regarding the community specific facilities, this village has one PHC. The village has one LP School. Three anganawadis are functioning in this village and two of them are functioning in rented buildings. This village has a network of 6 roads of length 3.950 Km, 2.80 Km drainage. The village has 14 street lights and only 3 of them are functional. About the fisheries specific infrastructure and facilities, it is noted that 230 country fishing boats and 28 mechanized boats are available in this fisheries village. And a total of 122 kerosene permits are issued to the fisher folk in this. The village has one market. The village has a protected coastal length of 1.00 Km. Consumption of liquor and narcotic drugs are moderate in this village.
