(Mararikulam South Grama Panchayat - Ariyadu Block)

A Brief Profile of the Chettikkadu Fishing Village

Chettikkadu fisheries village is spread over four wards of Mararikulam South Gram Panchayat. The coastal wards of this village are 11, 12, 13 and 14. The village has a total of 1573 houses and 1645 households are living there. Among them, 80 households are landless or presently living as a joint family. Regarding the housing situation in the village, it is noted that 45.33 percent houses are pucca, 47.23 percent are semi-pucca and 7.44 percent houses are kachha houses. About 90.46 percent of the existing houses in the village have sanitary toilets. Safe drinking water is available to 92.18 percent of the existing houses. Less than three fourth of the houses in the village (71.07 %) are electrified. It is noted that 441 persons from the fisher folk community are insured with the Fisheries Board (Matsya Board). And 19 persons are covered under the old age pension scheme and 6 persons are covered under widow pension scheme during 2007-08 in this village.

Regarding the community specific facilities, this village has one sub centre and one PHC. The village has two LP Schools. Six anganawadis are functioning in this village and three of them are functioning in own buildings. This village has a network of 19 roads of length 15.30 Km and 15.30 Km drainage. The village has 72 street lights and all of them are functional. About the fisheries specific infrastructure and facilities, it is noted that 75 country fishing boats and 9 mechanized boats are available in this fisheries village. And a total of 3 kerosene permits are issued to the fisher folk in this. The village has two ice plants and three markets. The village has a protected coastal length of 1.80 Km. Consumption of liquor and narcotic drugs are moderate in this village.
