A Brief Profile of the Puthiyappa Fishing Village

Puthiyappa South fisheries village is spread over two wards of Kozhikodu Corporation. The coastal wards of this village are 1 and 17. The village has a total of 2000 houses and 2054 households are living there. Among them, 60 households are landless or presently living as a joint family. Regarding the housing situation in the village, it is noted that 68.25 percent houses are pucca, 30.25 percent are semi-pucca and 1.50 percent houses are kachha houses. About 97 percent of the existing houses in the village have sanitary toilets. Safe drinking water is available to 82.60 percent of the existing houses. Most of the houses in the village (98.50 %) are electrified. It is noted that 986 persons from the fisher folk community are insured with the Fisheries Board (Matsya Board). And 1 person are covered under the old age pension scheme and 4 persons are covered under widow pension scheme during 2007-08 in this village.

Regarding the community specific facilities, this village has one PHC. Four anganawadis are functioning in this village and all of them are functioning in own buildings. This village has a network of 8 roads of length 9.30 Km. The village has 95 street lights and 60 of them are functional. About the fisheries specific infrastructure and facilities, it is noted that 76 country fishing boats are available in this fisheries village. And a total of 43 kerosene permits are issued to the fisher folk in this. The village has one guide light. The village has a coastal length of 2.50 Km, out of which 1.5 Km is protected. Consumption of liquor and narcotic drugs are acute in this village.
