

Puthiyappa North Fishing Village

(Elathoor GP-Chelannur Block)

A Brief Profile of the Puthiyappa North Fishing Village

Puthiyappa North fisheries village is spread over two wards of Elathur Gram Panchayath. The coastal wards of this village are 18 and 19. The village has a total of 860 houses and 916 households are living there. Among them, 61 households are landless or presently living as a joint family. Regarding the housing situation in the village, it is noted that 50.81 percent houses are pucca, 42.56 percent are semi-pucca and 6.63 percent houses are kachha houses. About 97.67 percent of the existing houses in the village have sanitary toilets. Safe drinking water is available to 80.23 percent of the existing houses. Most of the houses in the village (98.02 %) are electrified. It is noted that 431 persons from the fisher folk community are insured with the Fisheries Board (Matsya Board). And 11 persons are covered under the old age pension scheme and 3 persons are covered under widow pension scheme during 2007-08 in this village.

Regarding the community specific facilities, this village has no hospital facilities. The village has one Higher Secondary School. Four anganawadis are functioning in this village and three of them are functioning in rented buildings. This village has a network of 6 roads of length 4 Km, 2.10 Km drainage and one culvert. The village has 100 street lights and 80 of them are functional. About the fisheries specific infrastructure and facilities, it is noted that 95 country fishing boats are available in this fisheries village. And a total of 113 kerosene permits are issued to the fisher folk in this. The village has one harbour. The village has six ice plants and one market. The village has a coastal length of 2.5 Km, out of which 1.5 Km is protected. Consumption of liquor and narcotic drugs are moderate in this village.
