PROCEDURE FOR EMPANELMENT

Qualification Criteria for Fish Supply Agents

- 1) The Individual/ agency/Federations /firm should have minimum Five year experience in the supply of sea food items to major sea food exporting firms in Kerala.
- 2) The Individual/ agency/Federations /firm should submit proof of supply of fish to major exporting firms such as weighment slips, bills, payment receipts etc.
- 3) The Individual/ agency/Federations /firm should have an approved operational fish pre processing centre for pre processing fish either own or on lease.

Submission of Eol

Sealed EoI are invited from interested Parties/agency/Federations/firm /suppliers for supply of export quality Fish as specified in the Schedule attached herewith for a period of one year from the date of awarding of the supply order.

The EoI in a sealed cover superscribed "EoI for the supply of Fish" should reach The Managing Director, Kerala State Coastal Area Development Corporation, 'Makayiram', T.C 16/1709, Ulloor Lane, Near DPI, Jagathy, Thiruvananthapuram – 14 on or before 15.00 hrs on 04/01/2015.

The EoIs received so will be opened at 15.30 hrs on the same day.

This EoI is subject to following terms and conditions.

Terms and Conditions.

- 1. Supplier should supply the items at the Fish Processing Centre Nalapakom, Government Boat Building Yard, Shakthikulangara, Kollam or any other place specified by the Manager, Fish Processing Centre, Shakthikulangara from time to time.
- 2. Supplier should supply the items in good condition.
- 3. The supplier should supply the fish as whole, gutted, cleaned and split, fillets, chunks or any other form specified by the Manager, Fish Processing Centre. The pre processing should be carried out in an approved pre processing centre.
- 4. The fresh fish should be supplied in clean crates properly washed in fresh water and iced. If any items are found not in good quality, and not to the satisfaction of the concerned official, such items will be rejected on the spot and no payment will be made for it. The items should be supplied by the supplier on getting short notice/order from the authority on the basis of indent.

- 5. All the rights are reserved and rest with the Managing Director, Kerala State Coastal Area Development Corporation Ltd (KSCADC). In case of any dispute on the EoIs, the decisions of The Managing Director, Kerala State Coastal Area Development Corporation Ltd shall be final and binding in all respect.
- 6. Eols with the schedule can be down loaded from www.keralacoast.org or will be available at the Office of the Manager, Nalapakom Fish Processing Centre, Shakthikulangara, Kollam
- Indents will be placed to supplier for supplying the item at least 24 hrs. in advance at normal course. However in emergency, indents will be placed at any time depending upon the necessity.
- 8. If the supplier fails to supply the items at the place and time specified by KSCADC two times, KSCADC will have the right to terminate the contract without advance notice.
- 9. No representation for enhancement of price once accepted will be considered during the tenure of contract.
- 10. Lowest quotation will be accepted
- 11. No advance will be paid.
- 12. No transport charges will be made for the articles supplied under any circumstance.
- 13. The bidder shall fill the schedule and FORM -1 attached to this EoI document.
