## PROCEDURE FOR EMPANELMENT

EOIs are invited from all eligible and interested Firms / Individuals for Empanelment Of Alteration Work of Automobile Delivery Van/ Similar Vehicle as Mobile Vending Unit for Kerala State Coastal Area Development Corporation as per the following procedure:

Evaluation and short-listing of Individuals/agencies based upon the criteria mentioned hereafter and documents submitted

Presentation by short-listed agencies to selection committee for empanelment

#### A. DURATION OF EMPANELMENT

The empanelment will be valid for a period of two years. However, it may be further extended for one more year each subject to a maximum two years at KSCADC's discretion with the same terms and conditions.

#### B. QUALIFYING CRITERIA

- 1. To be eligible for pre-qualification, the applicant should be in the field of Automobile Conversion . This would include a Joint Venture company as well, meeting all other eligibility criteria.
- 2. They should also have at least 5 years post registration experience of providing Automobile Alteration services.
- 3. The applicant must have sufficient experience in the field of automobile interior designing and alteration
- 4. Financial Credibility.

#### C. INSTRUCTIONS & GUIDELINES FOR SUBMISSION OF APPLICATION FORM FOR EMPANELMENT

- 2 Application form for empanelment shall be submitted in sealed envelope super scribing "Application for Empanelment of Firms / Individuals Engaged in the field of Automobile Body Conversion For Empanelment Of Alteration Work of Automobile Delivery Van / Similar Vehicle As Mobile Vending Unit for empanelment with Kerala State Coastal Area Development" in the office of Kerala State Coastal Area Development Corporation Limited, Chalachithra Kalabhavan Building, 1<sup>st</sup> Floor, Vazhuthacaud, Trivandrum before the last date and time .
- 3 The application shall be submitted only as per the enclosed application format (s) along with annexures, Self attested documentary proof(s) in respect of the details furnished in the

application form shall be submitted along with the application.

- 4 As the time is the essence of a contract, the ability and the competence of the applicant to render required services in the specified time period will be a significant factor to decide the selection for the empanelment.
- 5 The application shall be signed by the person/s on behalf of the organization having necessary Authorization/ Power of Attorney to do so. Each page of the application shall be signed by the authorized signatory. (copy of Power of Attorney / Authorization shall be furnished along with the application)
- 6 While filling up the application with regard to the list of works completed and or on hand, applicants shall only include those works which individually cost as per pre qualification criteria mentioned in the form.
- 7 The applicant shall have to engage the services of well qualified specialists, wherever necessary.
- 8 Applications containing false and / or incomplete information are liable for rejection. At any point of time before, during or after the development, designing, implementation, execution, operation, monitoring phase of project, If KSCADC finds out that any detail or information submitted by the firm is false or wrong, then the firm would be discarded / disqualified from the panel and the firm would not be allowed to work further.
- 9 Selected applicants shall require executing an agreement with KSCADC in the prescribed Performa as in when directed to do so by KSCADC
- 10 Conditional proposals would be rejected without giving any further clarifications.
- 11 Managing Director, KSCADC shall have full powers to accept or reject the proposal in total or in partial, without assigning any reason.
- 12 Any matter / Question in regard to interpret any part or condition of this document OR any matter regarding definition of any term/s of the RFP, the Managing Director, KSCADC shall be the sole and final Authority to do so and the bidder is fully liable to it.
- 13 The empanelment shall be valid for a period of 2 (Two) years. The empanelment may be extended further at the discretion of MD, KSCADC.
- 14 The Application should be on the prescribed form. Certified copies of Award letters, completion certificates etc should be enclosed if any.
- 15 Applicants should give an undertaking certifying that the firm has not been blacklisted by any Govt. /Local bodies/PSUs.

#### D. APPLICATION FORM AND FEES

#### E. EVALUATION CRITERIA

- 2 The applicants will have to attend for a meeting for presentation in front of the Committee, and those shortlisted will be requested to submit the price bid through a closed e-tender for final selection.
- 3 Submission of satisfactory completion certificate from previous clients would assist the committee in evaluation.
- 4 KSCADC reserves the right to modify the criteria and take own decision if so required.
