- Detailed design and Detailed working/ shop drawing of Materials/ Components for Comprehensive Mechanical Ventilation System in proposed Hi-tech Fish Market based on the plan of building supplied
- 2) Detailed estimation of each components including detailed specification of Components (including potential brands) and materials required for the above
- 3) The associated Civil and Electrical works are also to be detailed as described in (1) and (2) above
- 4) Listing relevant standards, codes, laws and regulations relating to the design and operation of Mechanical ventilation systems as applicable in the state and details of any statutory clearances required
- 5) The Consultancy fee should be inclusive of all charges but exclusive of GST (The GST amount is to be separately specified)
- 6) Following checklists are to be submitted along with the bid:
 - a. Work completed during last 5 years in the field (please attach copies of award letter by client)

- b. Photographs/ Completion certificates of projects handled
- c. Financial Bid (fee for professional service) as lump sum amount
- 7) The successful bidder has to enter into an agreement with KSCADC in stamp paper worth Rs.200/- once the selection notice/ work order is awarded.
- 8) The entire work has to be completed within a period of 1 month from the date of award.
- 9) Payment terms will be as follows:
 - 10% of the total amount when a preliminary design is submitted within a period of 10 days
 - Balance 90% will be paid on submission of detailed report as per scope of work
- 10) The submitted documents will be the sole property of KSCADC and the bidder agrees to the same.

Pre Qualification (Eligibility) Criteria

- a) The Company/firm should have at least 5 years experience in similar works as detailed in scope of work
- b) The company/firm should have proven credentials to prove the above
